Worcester County Government is seeking volunteers to serve on a new Police Accountability Board, an Administrative Charging Committee, and a Trial Board.

Required by the Maryland Police Accountability Act of 2021, the Police Accountability Board will receive citizens' complaints of alleged police misconduct and forward them to law enforcement for investigation.

Once an investigation is completed, the Administrative Charging Committee will decide whether disciplinary action is warranted and offer recommendations for discipline in accordance with a state-mandated disciplinary matrix.

The Trial Board will conduct proceedings if an officer wishes to have a hearing to adjudicate the administrative charges brought by the Administrative Charging Committee.

All members must be:

- 21 or older;
- A full-time resident of Worcester County;
- A legal resident of the United States;
- Able to maintain confidentiality;
- Able to commit to an arranged amount of time each month; and
- Agree to a background check

We appreciate your interest in volunteering to serve our community. You must submit a resume with your application. If further information is needed, you will be contacted by a representative from this office. Only those who submit a completed application will be considered.

Applications will remain open continuously if you wish to be considered for future vacancies.
