TO ALL POTENTIAL 2026 MOSQUITO CONTROL PARTICIPANTS:

The County Commissioners of Worcester County Maryland have established a uniform fee of \$85.00 for each individual participant/residence for the adult mosquito truck spraying program, technically referred to as the adulticide (ULV) service for the upcoming mosquito spray season. This is a voluntary program and if you are interested in receiving this service then you will need to remit the \$85.00 fee via check made payable to "Worcester County" along with a completed program application to the address listed below. All participants must remit their payment along with the spray application diagram on or before May 1, 2026. Yard diagrams are required to be remitted each year. Please make the following note on the check, "Mosquito Control Services" to ensure your payment is recorded properly.

Please note that the program requirements are the same as in previous seasons. Monitoring of adult mosquito populations plus temperature, wind and rain are factors that determine if a spray application is completed. Yards will not be accessed when areas are too wet as determined by the spray truck driver.

**2026 MOSQUITO CONTROL SERVICES APPLICATION**

I/we hereby request mosquito control services during 2026 under the Integrated Pest Management Program sponsored by the State of Maryland and the County Commissioners of Worcester County Maryland

I/we acknowledge and agree to the following:

1. The Integrated Pest Management Program provides services on an as needed basis as determined by the State of Maryland Department of Agriculture through landing rate counts, weather conditions and label usage.
2. A Worcester County 911 address shall be made visible from the street at the entrance to the driveway, on the house or on a street level mailbox for driver identification.
3. Payment of \$85.00 and all attached applicant forms **MUST** be received by the County on or before **May 1, 2026**. Please submit all information by mail to the following:

4. All applicants receiving the services of this program shall provide a property map of the location where spraying is requested. The property map form, included herein, shall provide details showing (1) any areas to be avoided e.g. septic systems, fish ponds, low lying areas etc. (2) the driveway access to property plus (3) any structures such as homes, outbuildings, pool, etc. that the Mosquito Control driver needs to be aware of. The reflective stake placed at your mailbox by the Mosquito Control driver should be kept clear and visible for the driver. Yards will not be driven in when areas / yards are too wet.
5. All applicants or others that have made changes/alterations to the property to be sprayed after submitting this application shall request and provide a new map form detailing the changes. The changes may consist of but are not limited to landscaping, terrain, improvements, structures, driveways, treatment route etc. The revised property map form shall be submitted by the applicant to the above address within 24 hours following the changes made to the spray location. A new form may be obtained by contacting the Mosquito Control driver or the Mosquito Control foreman at 410-632-3767.
6. All spray routes are to be kept free and clear of any obstructions that may impede or affect the driver's ability to complete the requested spray treatment.
7. The State of Maryland and County Commissioners of Worcester County Maryland, and their personnel shall not be liable for any property damage or personal injury except by virtue of gross negligence or willful conduct.
